

INDEMNITY AND HOLD HARMLESS AGREEMENT

This Agreement made and entered into, by and between CRAMER QUARTER HORSES, INC., 8610 Padon Road, Needville, Texas, 77461, hereinafter designated "HORSE FARM," KAREN KENNEDY, ASHLEY RAY, CARA CAPLAN, NATALIE PAPE hereinafter designated "TRAINER/INSTRUCTOR," and _____ hereinafter designated "RIDER."

RIDER, by the execution of this Agreement, hereby acknowledges that he/she has been warned that livestock riding is and inherently dangerous activity requiring specialized skills, and said rider hereby agrees to assume all risks concomitant thereto.

UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AND INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.

RIDER hereby acknowledges reading the safety rules as shown by Exhibit "A" and agrees to indemnify and hold harmless HORSE FARM, TRAINER/INSTRUCTOR, their agents, contractors, partners, employees, or assigns, without regard to the negligence, if any, of HORSE FARM, TRAINER/INSTRUCTOR, their agents, contractors, partners, employees, or assigns, against any and all claims, losses, judgments, demands, damages, costs, and expenses, including attorney's fees for the defense thereof, or injury to or death of any person or persons, or livestock, arising from the TRAINER/INSTRUCTOR's or RIDER's use of livestock or from the TRAINER/INSTRUCTOR's or RIDER's use of the CRAMER QUARTER HORSES, INC. facility or from any act or negligence of the TRAINER/INSTRUCTOR or RIDER, their agents, guests, or invitees in/out or about the premises.

EXHIBIT "A"

RULES AND REGULATIONS

1. Riders are recommended to wear hard hats while riding.
2. No riding without a bridle.
3. Shoes with heels should be worn while riding.
4. Tack and personal equipment is to be kept in designated areas.
5. Horses are to be tied only to designated cross-ties. Do not leave horses unattended in cross-ties.
6. Riders are recommended to not ride alone.
7. Blankets must be removed from the premises by all boarders during the summer months and returned clean and repaired in the fall.
8. No running or playing in the barn.
9. No pets allowed on the premises without permission.
10. No smoking in or around the barn.
11. Telephone usage should be kept to a minimum.
12. Turn off the lights and fans that you turned on, when you are finished.
13. No guests or small children are to be left unescorted.

Lesson Prices:

Pay as you go – \$60.00 per lesson
Lessons **MUST** be paid for at the time of the lesson.
Late payments will be \$5 per lesson

Pre-Pay package – \$200 for the month (4 lessons)

Cancellation Policy:

Any lessons cancelled on *behalf* of Cramer Quarter Horses due to weather or show conflicts will be given a makeup.
